

Fares Rules

The table below is intended as a guide only to the Eastern Air Services (EAS) fare and costing structure.

Unless we state otherwise dollars or '\$' is a reference to Australian dollars and any applicable GST is included.

Booking Changes (including No-show)	Changes greater than 2 weeks before Departure): <ul style="list-style-type: none"> changes can be made on-line at the EAS website, by contacting our office on 1300 359 327 or contacting an Authorised Agent; your original fare may be used as credit towards the payment of a new fare of equal or higher value, provided the new fare conditions are met; at the time of making the change you must pay the Booking Change Fee applicable and any fare difference between the fare for your new booking and the original fare; your new booking must be for travel anywhere on the EAS network within 12 months of the date the original ticket was issued. However, you cannot use the credit to re-book and travel on the same day; and the original ticket value is non-refundable and remains non-refundable at all times. Changes within 2 weeks of Departure: <ul style="list-style-type: none"> Not permitted - Loss of fare. 	Changes 72 hours before the scheduled departure time: <ul style="list-style-type: none"> changes can be made on-line at the EAS website, by contacting our office on 1300 359 327 or contacting an Authorised Agent; your original fare may be used as credit towards the payment of a new fare of equal or higher value, provided the new fare conditions are met; at the time of making the change you must pay any fare difference between the fare for your new booking and the original fare; and your new booking must be for travel anywhere on the EAS network within 12 months of the date the original ticket was issued. Cancellations (including no show)	<p>Before the day of scheduled departure:</p> <ul style="list-style-type: none"> re-booking – see ‘Booking Changes’ above; ticket value can be used towards a new booking of equal or higher value for travel anywhere on the EAS network within 12 months of the date that the original ticket was issued. This credit must be used within 12 months of the date the original ticket was issued.
